

International Student Fee Schedule 2021

1. Overview

This Fee Schedule outlines tuition fees for higher education at the Australian Performing Arts Conservatory (APAC), and other charges related to studying at the Conservatory. All fees referred to in this schedule are in Australian Dollars, unless otherwise specified. Payment of fees is outlined in the *International Student Fees Policy*. Tuition fees may be refundable in certain circumstances. Refer to the *International Student Refund Policy*

3. Tuition Fees

Bachelor Screen and Stage (BSS) courses

Tuition fees can be defined as fees payable for tuition as officially published or provided by the Conservatory. Tuition fees and other charges are set each year and will apply at the time that a letter of offer is issued and are subject to annual review. The following tuition fees apply to January 2021 intake.

4. Administrative and Miscellaneous Fees

Administrative and miscellaneous fees and charges are non-refundable. These are charged separately to tuition fees. A list of fees is outlined in the *International Student Fee Policy*.

5. Payment of Fees

6. Definitions

Census Date: The official date the financial liability for courses is set and tuition fee is due for students. Census dates are determined for each term and are published on the Conservatory's website.

Credit transfer is a process that provides students with agreed and consistent credit outcomes for components of a qualification based on identified equivalence in content and learning outcomes between matched qualifications (Australian Qualifications Framework definition).

Due Date: The deadline for payment of fees as shown on the invoice for students, and also listed in the *Letter of Offer* and *APAC Student Agreement*.

Full-time Study Load: Standard full-time study load for a particular course.

Recognition of prior learning (RPL) is a process used to assess an individual's relevant prior learning (including formal, informal and non-formal learning) to determine the credit that may be granted towards completion of a qualification (adapted from Australian Qualifications Framework definition).
